Summary: Inmate Juventino Ahuatcabrera was booked into the Intake Release Center on June 2, 2021 at 1118 hours. On August 20, 2021 at about 1005 hours, inmates housed near Ahuatcabrera attempted to wake him for the physical body count. Inmate Ahuatcabrera was unresponsive and inmates alerted deputies who were conducting the count. Deputies assessed inmate Ahuatcabrera and began CPR. Ahuatcabrera was transported to the UCI Medical Center via paramedics. While at UCI, Inmate Ahuatcabrera was unable to be resuscitated.

On August 20, 2021 at 1110 hours, UCI MD Eric McCoy pronounced Inmate Ahuatcabrera deceased.

This letter is serving as notice to the Department of Justice of the death of an inmate in the custody of the Orange County Sheriff's Department on August 20, 2021.


Inmate Juventino Ahuatlcabrera, booking number 3200621 was booked into the Orange County Jail Intake and Release Center on June 2, 2021 at 1118 hours. He was arrested by Orange County Probation for a violation of probation (PC1203.2) on case 18CF3419. Additionally the court remanded him on case 21WM08472 for VC23152(A), 23152(B) and VC20002(A). He was given credit for time served on case 18CF3419 and was scheduled to return to court on September 9, 2021.

On August 20, 2021 at about 1005 hours inmates housed near Ahuatlcabrera attempted to wake him for the physical body count. Inmate Ahuatlcabrera was unresponsive and the inmates alerted the deputies that were conducting the count. Deputies assessed inmate Ahuatlcabrera and began CPR.

Inmate Ahuatlcabrera was transported to UCI Medical Center via paramedics. At approximately 1110 hours on August 20, 2021 Dr. Eric McCoy pronounced inmate Ahuatlcabrera deceased.

The cause of death is pending. The autopsy will be performed on September 2, 2021 at 1100 hours by Dr. Luzi. For additional information, please contact Commander T. Morris at 714-647-7440
