## INTERNAL MEMO

### **Summary:**

On 6-15-21, at 0950 hours, Costa Mesa Police Department arrested Curcio, Andrew (12-24-90) for CPC 1170(H) (5), warrant number 21WF0308. Curcio was booked into the Intake Release Center on 6-15-21, at 1423 hours.

On 6-16-21, at 1150 hours, Curcio was transferred to the Theo Lacy Facility and housed in Module Q, Sector 52, Cell 15.

At about 2005 hours, deputies went to Curcio's cell because he did not respond to medication call. When deputies entered the cell they found Curcio on his bunk unresponsive and not breathing. Deputies, via radio, requested Theo Lacy Medical and City of Orange Fire Department #6 to respond. At 2026 hours, Orange City Fire Department Engineer Medic D. Rynearson pronounced Curcio deceased. All department notifications were done per protocol.

### **Medical History:**

Due to HIPPA regulations, detailed medical information could not be obtained at this preliminary stage

This letter is serving as notice to the Department of Justice of the death of an inmate in the custody of the Orange County Sheriff's Department on June 16, 2021.

Inmate Curcio, Andrew, booking number 3202088, was booked into the Orange County Jail Intake and Release Center on June 15, 2021 at 1423 hours by Costa Mesa Police Department. He was booked on a warrant for HS1170(H)(5) with No Bail. His first court appearance would have been on June 17, 2021.

On June 16, 2021 at approximately 2005 hours, deputies went to Curcio's cell because he did not respond to medication call. When deputies entered the cell, they found Curcio on his bunk unresponsive and not breathing. Deputies, via radio, requested Theo Lacy Medical and City of Orange Fire Department #6 to respond. At 2026 hours, City of Orange Fire Department Engineer Medic D Rynearson pronounced Curcio deceased.

The cause of death is pending. The autopsy will be performed on June 23, 2021 by Dr. Luzi. For additional information, please contact Commander T. Morris at (714) 647-7440.
