Summary: On September 18, 2015, Flores was arrested by Placentia PD for 3 misdemeanor warrants. The warrants were for Placentia Municipal Code Violations for Alcohol in a Park. Flores was booked into the Intake & Release Center on the 18th at 0706 hours. He was housed at the Central Men's Jail on the 19th at 0103 hours.

On September 20, 2015 at 0400 hours, Inmate Flores was seen by IRC medical staff for [REDACTED]. After further evaluation, Flores was sent to Anaheim Global Medical Center for observation. The medical aid was written under JI IR092015/0400 and DR 15-208263 by Deputy Wiggs.

On September 21, 2015, Flores was moved to the CMS Jail Ward.

On September 23, 2015, Flores was moved to Anaheim Global Medical Center, ICU #8 for [REDACTED]. At about 2100 hours Flores went into cardiac arrest, flat-lined, but was resuscitated.

On September 24, 2015 Anaheim Global Medical Center requested next of kin information for Flores and stated Flores was not doing well.

On September 24, 2015, at about 2219 hours, Flores went into cardiac arrest. Hospital personnel performed Cardio Pulmonary Resuscitation to no avail. At about 2234 hours, Flores was pronounced deceased by Dr. C. Chang. Deputy R. Cash was present during the time of death. Deputy Cash remained at the scene with Flores until the Coroner and Sheriff's Homicide arrived.



Medical History:

Medical protocols prohibit access to Inmate Flores' medical records at this time. However Flores was booked on alcohol related warrants. On September 20, 2015, he was seen by the Intake & Release Center medical staff and sent to Anaheim Global Medical Center for [REDACTED]

This letter is serving as notice to the Department of Justice of the death of an inmate in the custody of the Orange County Sheriff's Department on September 24, 2015.

Inmate Flores, Yasir booking number 2903032 was booked into the Orange County Jail Intake and Release Center on September 18, 2015 by Placentia Police Department. He was booked on three cases. Case numbers 15NM08974, 14NM11287 and 15NM07345 for the charge of MC PL14.08.120 Alcohol in Park on all three cases. He had a total bail of \$16,500.00 and was scheduled to go to court on September 25, 2015 in Central Justice 1.

On September 20, 2015, inmate Flores was seen by the IRC medical staff and after further evaluation, he was sent to Anaheim Global Medical Center for observations.

On September 23, 2015, inmate Flores was moved to ICU and at approximately 2100 hours, he went into cardiac arrest, flat-lines, but was resuscitated.

On September 24, 2015 at approximately 2210 hours, Flores went into cardiac arrest. Hospital personnel performed Cardio Pulmonary Resuscitation to no avail. Approximately 2234 hours, he was pronounced deceased by Dr. C. Chang.

The cause of death is pending. An autopsy will be performed on September 26, 2015 by Dr. Luzi. For additional information, please contact Captain Osborne at 714-647-7440.
