**SUMMARY**

On Tuesday, May 21, 2013 at 1638 hours, I was notified by Sergeant T. Wayne that Inmate Holliday (2765185) was pronounced deceased by Doctor R. Cuenca at Western Medical Center/Santa Ana (WMCSA) at 1637 hours. Deputy Hunter (Theo Lacy) was on scene at the time of death. Holliday had been housed at WMCSA and Western Medical Center/Anaheim (WMCA) since 5-18-13.

Inmate Holliday was transferred to WMCA from Theo Lacy on 5-18-13. He was admitted for [REDACTED] He was eventually [REDACTED] Hospital staff requested the Sheriff's Department notify next of kin, which I did. Special visiting arrangements were made for Holliday's next of kin.

**IN CUSTODY HISTORY**

Inmate Holliday was arrested by OCSD Stanton Police Services Deputies on 5-16-13. He was booked at the IRC and eventually housed in Module "C" at the Main Jail. Holliday was transferred to Theo Lacy on 5-18-13 and housed in "G" Barracks.

While in "G" Barracks, an LVN saw Holliday acting bizarre and he was referred to medical for evaluation. The Theo Lacy RN referred Holliday to WMCA for further evaluation related to [REDACTED]

This letter is serving notice to the Department of Justice of the death of an inmate in the custody of the Orange County Sheriff's Department on May 21, 2013.

Inmate Holliday, Jason James, booking number 2765185 was booked into the Orange County Jail Intake and Release Center on May 16, 2013 by Orange County Sheriff's Department (North Patrol). He was booked on a bench warrant for PC647(F) with a bail amount of \$15,000. Due to medical problems, inmate Holliday never went to court.

On May 18, 2013, inmate Holliday was transported to Western Medical Center in Anaheim by ambulance and was admitted into the hospital. On May 19<sup>th</sup>, he was transferred to ICU.
