This letter is serving as notice to the Department of Justice of the death of an inmate in the custody of the Orange County Sheriff's Department on September 1, 2019.

Inmate Moreno, Robert Anthony, booking number 3073988 was booked into the Orange County Intake and Release Center on August 27, 2018 at 2200 by La Habra Police Department. He was booked to a felony street charge of PC211 with a bail amount of \$50,000.

On August 29, 2018 he was booked to a Probation Warrant (PC1203.2), case number 16NM16160 with a bail amount of \$15,000.00. Also, on December 19, 2018 he was booked to a Remanding Order (PC272(A)(1), PC311.11(A) and PC311.10(A)), case number 18NF3452 with a bail amount of \$20,000. He was scheduled to go to North Justice Center court on September 25, 2019 on all three cases.

On August 31, 2019 at approximately 2019 hours, Inmate Moreno's cell mate pushed in-cell emergency call button to report inmate Moreno was down. Deputies responded and found Moreno cold, blue and without a pulse. Medical staff was requested and life saving measures were immediately started. Multiple doses of Narcan were administered with no effect. Orange Fire arrived and took over lifesaving efforts. No pulse was detected. Moreno was transported to University of California, Irvine Medical Center (UCI) in Orange. UCI requested next of kin notification to authorize removal from life support.

On September 1, 2019 at 0136 hours, Moreno was pronounced deceased by Dr. Heather Hoffman.

The cause of death is pending and the autopsy will be performed on Friday, September 6, 2019 at 1000 by Dr. Luzi. For additional information please contact Captain T. Morris at 714-647-7440.
