Summary:

On 1-24-16 at 0520, un-sentenced inmate RUSSELL approached the West Watch, stating that the chest pains he was having on 1-23-16 were re-occurring and he wished to be re-examined by our medical personnel. (He was previously evaluated by our medical staff on 1-24-16 at 0003, sent to the IRC for further monitoring and returned here to the James A. Musick Facility 1-24-16 approximately 0200.) He was examined and sent back to his housing at 0700. At approximately 1020, he re-approached the watch and requested to be again examined by our medical personnel. He was under observation by our medical personnel in the dispensary when he became unconscious at approximately 1220. Our medical staff called the adjacent West Watch, began life-saving steps and received help within 30 seconds by our on-duty deputies. He was transported to Hoag Hospital Irvine at 1243. He succumbed to this medical emergency in the care of Hoag Hospital medical professionals at 1336.

Inmate RUSSELL was involved in no Uses of Force, and not the suspect or victim in any known assaults or altercations while in custody.

Medical History:

Inmate RUSSELL suffered from no known or diagnosed medical conditions other than [REDACTED]

Notifications:

I notified the James A. Musick Facility's Facility Commander Captain Krueger of the incident at 1345 hrs. Department Commander Lieutenant J. Roche made notifications as per protocol.

Other notifications were:

Assistant Sheriff Kea and Commander Bland were notified by the James A. Musick Facility Commander. The Board of Supervisors and the Office of Independent Review were notified by Department Commander Lieutenant Roche.



The required Email notifications were sent to Orange County Public Defender Frank Ospino, Jean Wilkinson and Denise Gragg in two different avenues of email. I received a response stating they were either no longer working at the office. The third attempt was returned to me stating the server was down.

Inmate records compiled and copied the inmate files for the custodial death.

This letter is serving as notice to the Department of Justice of the death of an inmate in the custody of the Orange County Sheriff's Department on January 24, 2015.

Inmate Patrick Russell booking number 2919121 was booked into the Orange County Jail Intake and Release Center on January 8, 2016 at 1057 hours by OC Probation Dept. Inmate Russell was arrested on a PC1203.2, probation violation for cases 14HF2325 and 14WM09497. His cases were heard on January 12, 2016 and several times since then. His next court appearance was scheduled for February 11, 2016 in Central Superior Court dept. 58.

On Sunday January 24, 2016 at approximately 1220 hours, Inmate Russell became unconscious at the medical dispensary while under observation for chest pains. Medical staff began live saving steps and received help from the on-duty deputies who from the West Watch that responded to Medical's call. Inmate Russell was transported to Hoag Hospital where he was pronounced deceased at 1336.

An autopsy will be performed on January 31, 2016 by Dr. Luzi. The cause of death is pending. For additional information, please contact Captain Robert Osborne, Chief Coroner at (714) 647-7440.
