- Math Instructional Coach: \$117,718

- Professional Development - Mastery Learning and Grading Implementation: \$14,850
- Professional Development - Notice & Note: \$18,926
- Professional Development - Responsive Vocabulary: \$33,857
- Magnet School of America Conference: \$18,000
- College Board Advanced Placement Summer Conference Attendance: \$12,000
- College Board Annual Conference Attendance: \$18,000

**The school also has \$411,327 of carryover funds from last year to spend this year.**

**The school must "use it or lose it" so tell your Principal how to spend the money to support high need students!**

Beginning in the 2017-18 school year, the Community Coalition v. LAUSD lawsuit settlement provides \$150 million of additional funds to 50 middle and high schools in Los Angeles over 3 school years to invest in resources and programs that support high need students.
