APPENDIX A RESEARCH METHODS

The findings in this report are based on a comprehensive review of the Local Control and Accountability Plans ("LCAPs") approved for the 2019-20 school year for unified, elementary, and high school districts in the counties of Los Angeles, Riverside, and San Bernardino. The research was conducted as a collaboration between Public Advocates, ACLU Foundations of California, and Gente Organizada. Youth at Gente Organizada participated in every step of the research process, from coding the data to selecting research questions to explore, to shaping the toolkits used in this report. This collaborative research between community activists, policy advocates, and researchers with academic training follows the model of Participatory Action Research. The three counties were chosen because of their proximity to the original action in Pomona advocating for student supports instead of police and "security," and because together, they serve nearly one-third of California's students.

Approved LCAPs for each California county can be found on the County Office of Education websites.² Districts should also make the LCAPs readily available on the district website; but, in some cases, the LCAPs may be difficult to find, out-of-date, or unavailable on these websites. The team downloaded all LCAPs and reviewed each one. Group members then coded the LCAPs for analysis by reading them and entering information into a spreadsheet. The information pertained to the LCAPs report on funds actually spent for the 2018-19 school year and/or planned expenditures in the 2019-20 school year, in the following areas: whether the LCAP funded police,³ non-police security,⁴ security equipment,⁵ or Restorative Justice & Positive Behavioral Interventions and Supports; whether these items were funded by base funds or supplemental and concentration grants designated for high-need students;⁶ and how supplemental and concentration grants for these items were allocated and justified.

Because LCAPs tend to be hundreds of pages in length, coding was labor-intensive. The LCAPs were coded by multiple coders in the first round of coding, and the first-round coders completed the spreadsheet and marked the location of pertinent items on an electronic copy of the LCAP. In the second round, four members of the research team reviewed all LCAPs to ensure that all coding was accurate. After coding was completed, a researcher cleaned and analyzed all data using IBM SPSS software. The researcher also added student demographic data and district support personnel data available from the CDE to the dataset for comparison analysis. All group differences shown in this report were found using appropriate statistical analyses – t-tests and chi-square analysis – and are significant at the p<0.05 level or better.

- 5 An action was coded as "security equipment" if it was a non-personnel resource designed for physical security, such as security cameras, alarms, fencing, K9 units, and visitor management systems, such as Raptor and LobbyGuard. Security software designed to protect computers was not included, although those services also should not be purchased with S&C funds.
- 6 If an action was included as contributing to the meeting the Increased or Improved Services Requirement in the Goals, Actions, and Services section of the LCAP, it was coded as S&C funded.
