- I believe the best thing we can do to to secure sexual & reproductive health in our district is first keeping the money that funds these programs in the district, by doing this we can keep more actability of where the money is being used. What we must also realise is even if the Fed cuts funding, the programs can still be funded by us. We must remind ourselves that after-school care, teen pregnancy,etc is the responsibility of the community and we must personally get involved.
- 2. A. To affirm the humanity of all people not just transgender people, we must start treating everyone like individuals, and not treat people differently because they may look, talk or believe differently than you. The best thing policy makers can do is make sure the law is blind and treats everyone the same.

B. I want to stop the transfer of power/money from our communities to Sacramento, by doing this it will empower communities of color and give us the means to take care of ourselves. The thing we must realize with dealing with white supremacy is hate can not get rid of hate, we must do something hard and get to know the white supremacies and once we get to know each other as just human beings, the hate will start to disappear.

3. Yes, the government has to be transparent and open to the public. By being transparent the people can keep the government accountable.

4. Yes, California needs to change its laws so that law enforcement's use deadly force only when reasonably necessary. But if we want to end police brutality we have to do two things end the war on drugs, which is the cause of so much harm in our communities. Second patrol our own communities, to prevent crime.
