The only legally permissible enrollment procedure is a random drawing when there are more applicants than seats. Preference in the drawing may be given based on local residence only and under specific circumstances (California Education Code Section 47605(d)).

After completing this form, submit one copy with the school principal and one copy with the charter authorizing agency (search your school by name at <u>http://www.cde.ca.gov/ds/si/cs/ap/lists.asp</u> to find the authorizing agency under the heading "district"). If the school and authorizing agency fail to remedy the problem, send a copy of the form and any correspondence with the school and/or authorizing agency to the superintendent of your local county office of education.
