**1. KITCHEN:**

SPOs Krenk, Powers, DM Williams, I.S. Maschke and Patrice have the User I.D. and Password for Jeff Mashtal's computer in the event that the Nutrikids program needs to be reviewed.

**2. LAUNDRY:**

I.S. LoGrasso spoke with Laundry staff who stated that the Yellow and Turquoise shirts are not to be placed in the same wash due to the colors bleeding. I.S. LoGrasso stated that she would send an e-mail to staff regarding this issue prior to reviewing the procedure with someone from Youth Facility.

**3. MEDICAL:**

SPO Krenk requested that all documents or copies of documents regarding Medical Issues and Nursing staff be forwarded to her.

A youth who has been booked into the Juvenile Detention Facility and has been diagnosed as having lice are to be treated for the lice by nursing staff immediately. The youth is not to be housed in Med. Iso. The nurse does not need Doctor's Orders prior to administering lice treatment.

**4. PAFs:**

More detailed information is to be incorporated into the PAFs. Revisions have been made to the PAF form to include a page where staff's Goals for Improvement are given a score in all areas of staff's duties. The scores are added together and an average is figured which will be the rating score. This page is to be attached to the PAF as the last page. Supervisors are to meet with their staff on a monthly basis or have an I.S. who works on the same shift as your staff document meetings, make entries in the staff's Work Site File, let your staff know that they are appreciated. Also hold staff accountable for negative actions.

All PAFs are to go to Patrice to be logged in on her spreadsheet before they are given to the DM or the I.S., this is done for tracking purposes.

**5. PURCHASE ORDERS:**

All haircuts that are not paid for by the youth's parent/guardian are to be submitted on a Purchase Order. A Haircut Log is to be created by Patrice and placed on the 'G' drive for I.S.s to view.

**6. RELIGIOUS VOLUNTEERS:**

Jail Ministries is being contacted to provide Religious Services to the facilities in place of Religious Volunteers. DM Williams is to create a packet for Chief Bonwell using the Jail Ministries Professional Agreement and the contract from the Sheriff's Department. P.O. Mike Wallace has been working on acquiring information on this project.

**7. REPORTS:**

**DISCIPLINARY REFERRALS:**

Disciplinary Referrals involving Youth being sent to the Disciplinary Review Board are to be forwarded to SPO Powers box in the Admin. office. The Refer to DRB box is to be checked and the youth is to sign the Disciplinary Referral form where it states ACKNOWLEDGEMENT of DRB referral Youth's Signature. If the youth refuses to sign the officer states on the signature line Refused.

**CONSEQUENCE REPORTS:**

Staff are to call the Duty I.S. and request to write a consequence report and recommend discipline, the Duty I.S. is to review the consequence report and recommended discipline prior to signing the report to instill discipline.

A youth who gets a Roster today and gets a Consequence tomorrow shall not receive any more Rosters until the beginning of the following week.

Youth who are over-sprayed during an incident but not actually involved in the incident

are not to be mentioned in the Incident report. The youth shall be mentioned in the I.S. Pass Down Log and are to be decontaminated and checked by the nurse.

**8. SCHOOL:**

Ms. Valdivieso stated to I.S. Kerrigan that officers are not always in the classroom while class is in progress. In Pod 5 officers are to be in the classrooms, in Pod 1 it depends on which youth are attending class.

The teachers are to create a write-up for each youth removed from class. The I.S.s are to review surveillance video to ensure that the video and the write-up correspond.

**9. SUPPLIES:**

Michael Willnow, Stock Clerk, will stock and reorder the Loops toothbrushes and the toothbrush holders in the warehouse. When the youth is released from custody the toothbrush and toothbrush holder shall be discarded. If the youth is transferred to the Youth Facility the toothbrush and toothbrush holder will be sent to the Youth Facility with the youth. If the youth transfers back to the Juvenile Detention Facility the toothbrush and toothbrush holder will also return with the youth.

**10. STAFF:**

Staff working in Unit 5D are to be briefed on the importance of being observant and not to become lax in their observation of the youth. Some staff have become complacent with youth in the unit.

I.S.s are to set expectations to staff. Discourtesy between staff members will not be tolerated. Documentation of staff discourtesy is to be made in Staff's Work Site File and cc: the DM and SPOs. There will be no verbal contacts for discourteous treatment.

Staff are to be briefed on the issue of calling Code 4 while an incident is still in progress. Only an I.S. shall call Code 4 indicating that no further assistance is needed. The I.S. is to include this issue when setting expectation to staff.

**11. TIME SHEETS:**

TCiCT is currently working on Electronic Time Sheets which will be completed on the facility computers and e-mailed to the Facility Scheduler, currently I.S. Yeates, for review and forwarded to the Payroll Account Clerk. The program is expected to be available in a couple of months.

**12. TRANSPORT:**

Transport officers are to be questioned regarding youth wearing sandals to court.  
Inmates at TCSO wear sandals to court.

Jumpsuits are for Direct Files only to wear to court.

When a youth is released from custody, if there is an appointment for a transport, the appointment is automatically cancelled upon release from Caseload although the court date remains in the youth file. If the youth is brought back in from outside, transport staff are not aware that the youth need to appear in court since the appointment automatically cancelled at the time of release. The appointment must be re-entered in Caseload if the youth is brought back into the facility.

### **13. YOUTH:**

Youth who have been placed on Jeopardy Track or Gang Track are not to have a roommate.

Youth currently housed in Unit 5D are also not to have a roommate, per SPO Powers.

Visalia Police Department attempted to leave a 12 year old in the custody of the Juvenile Detention Facility for booking, SPOs Krenk and Powers were called, the booking was denied.

All youth booked into the Juvenile Detention Facility who are 13 years old or younger are to complete a Gladys R questionnaire during the booking process. The Gladys R questionnaire is located on the 'G' drive in the Juv\_Hall Folder, in the Forms Folder.

Youth are to be searched both before and after visits. A briefing for staff is to be written and forward it to SPOs Krenk or Powers for distribution to staff.

I.S. Maschke stated that during an incident which occurred on Tuesday, August 15<sup>th</sup>, in the evening, a pregnant youth attempted to get out of the unit due to the use of O.C. Pepper Spray. The youth stated that she was unable to go into the cover position due to being pregnant. Officer Ji. Martinez, Lead Officer, called out not to spray her due to her being pregnant. I.S.s Kerrigan and LoGrasso are to question the youth and call Medical if necessary.

Youth Facility no longer has 3-day holds. A Youth Facility youth may be placed on Room Confinement at the Juvenile Detention Facility with the Admin. Hold form from Youth Facility staff and 4 hour reviews documented in Caseload. If the Admin. Hold form is received and states 3-day hold, the DM and SPOs are to be informed.

Differences between Program, General Population, Jeopardy Track and Gang Track. In program youth do not get consequences while on Jeopardy Track, Youth in General Population do get consequences while on Jeopardy Track. Discipline is to be determined

on a case-by-cases basis.

When setting expectation to staff, make sure that staff know that they are to inform the I.S. immediately any time a youth refuses to take their medication.

A restriction that goes from a Safety Restriction to Room Confinement must have an entry in Caseload in the 4-hour review for the Safety Restriction stating “Not to Continue” to close the previous restriction and then the youth is placed on Room Confinement with 4-hour review.

**1. HYGIENE:**

SPO Powers bought a plastic bin, drilled holes in the bottom to store toothbrushes and toothbrush holders. A bin will be created for each unit having up to 24 holes for toothbrush holders. The bins will help keep the youth's toothbrushes clean and will help prevent mold.

**2. INCIDENT REPORTS:**

I.S. Maschke completed an O.C. audit reviewing all Incident Reports for the fiscal year '16-'17. A note stating O.C. used was inserted in those Incident Reports where O.C. Pepper Spray was used but not documented. Only one youth is to be listed on each O.C. Log. Youth who received an overspray of O.C. Spray are not to be listed on an O.C. Log. Youth receiving overspray of O.C. shall be documented in the I.S. Note at the bottom of O.C. Log, "Youth was over-sprayed during an altercation".

A similar form will be coming for Restraint Log, Restraint Chair, Safety Cell, and Wrap from January forward and Strip-searches.

SPO Powers asked that he be notified, by e-mail, when an Incident Report has been completed so that he can review the report.

When writing an Incident Report, staff and youth are to be quoted including cursing and gang slurs.

When a Critical Incident or Use of Force incident occurs PCO staff are to be debriefed by an I.S. and I.S.s are to brief SPO Powers on the incident. SPO Powers can be briefed by e-mail. An I.S. shall not undermine an Officer's Incident Report based on watching the incident on the recorded surveillance videos. Grievances and Complaints can be determined by watching recorded videos but not Incident Reports.

An e-mail is to be sent to all I.S.s, the SPOs, and DM when a Critical Incident occurs, i.e., suicide, major fights, assault on staff, etc.

**3. I.S.s:**

SPO Powers distributed a page of Institution Supervisor (IS) Expectations. The expectations are to be read and signed-off by the I.S.s and returned to SPO Powers. Any I.S. needing this page can find it at the bottom of these minutes. The page may be printed out and signed.

SPO Powers stated that the I.S.s are now to meet with their staff on a monthly instead of a quarterly basis. Staff Contacts are to be viewed as Training instead of a Write-up.

All major issues are to be sent via e-mail to the SPOs and the DM.

SPO Powers spoke on program rules, jeopardy track and gang track.

All activities must be documented keeping all other I.S.s informed of what is occurring in the facility.

The I.S.s are to be in the Pods supervising staff as much as possible.

**4. MEDICAL:**

Nursing staff are to be available in the facility at all times. SPO Krenk has discussed this issue with Medical staff. If a booking occurs during lunch time, nursing staff are to respond to the call and may continue their lunch after they have responded and conducted a pre-medical clearance of the youth. According to our contract with Corizon we are to have 24/7 on-site nursing staff. If issues continue to occur a memo is to be sent to SPO Krenk and CC: SPO Powers and DM Williams. Include names, dates, times, as much information as possible in the memo.

**5. PAFs:**

All PAFs must be given to Patrice so that they can be logged-in on her spreadsheet for tracking purposes. All PAFs will be scanned by Patrice in the event that the PAF becomes lost.

SPO Powers asked that all PAFs from his staff be e-mailed to him instead of printed out and placed in his mailbox.

**6. POSTINGS:**

All postings, Post Orders, Staff Briefings, etc. must be approved by the DM or SPO prior to placing the postings on the wall.

**7. STAFF:**

Some PCO staff have requested temporary accommodations. Only the Chief can grant special accommodations.

**8. YOUTH:**

BIR Holds do not program until they are Medically Cleared.

**CLASSIFICATION:**

A Classification Log is to be completed each time a youth is moved from one unit to another unit regardless of length of time spent in another unit.

For youth from the Youth Facility the term '3 Day Hold' will no longer be used. 'Admin. Hold' is to be used with 4 hour reviews.

**OVERFLOW:**

The overflow from unit 5B, population of 24, shall be housed in unit 5A, upstairs, with a split program.

**PARENT/GUARDIAN CONTACT:**

Parents/guardians are to be notified when a youth is involved in an altercation and the youth is seen by Medical staff, the youth is placed on a restricted program and the youth loses recreation time, is on suicide level, etc. If the youth is taken on a transport to the hospital the parent/guardian may attempt to see the youth, the parent/guardian is to be contacted and informed after the youth has returned to the facility.

Discussion took place regarding acquiring an Automated Notification Recording system to send recordings to parents/guardians of youth being housed in the facility informing the parent/guardian of restricted program due to the youth's behavior or other information to be passed on. This Automated Notification system is already in use by many schools. SPO Powers stated that he would look into acquiring this type of system.

## **Institution Supervisor (IS) Expectations**

1. IS's are expected to know and comply with Probation Department Policies and Procedures, Title 15 regulations, and all Juvenile Detention Facility Policies and Procedures, including the various Program Manuals utilized in the facility.
2. IS's are expected to remain professional at all times (pursuant to P&P Rule 4.11) and are expected to set an example to staff.
  - a. If an IS has a grievance or complaint regarding a staff or working condition that grievance or complaint should be brought forward to a supervisor and never discussed with subordinates.
3. IS's are expected to know and comply with all staff scheduling rules, including those regarding flex time, voluntary overtime, and involuntary overtime.
  - a. Any alteration made to the schedule shall be immediately reported to the scheduling IS.
  - b. Do not flex schedules unless approved by scheduling IS.
4. IS's are expected to know and comply with Progressive Discipline procedures for youth.
  - a. Use of Roster, Consequences, and Incident Reports
  - b. Use of Jeopardy and Gang Track
  - c. Use of RC or Safety Restriction
  - d. Separation Logs
5. IS's are expected to have daily communication with supervisors, peers, and staff regarding pertinent information; including staffing concerns, staff assignment, staff needs, and concerns with youth.
  - a. Staff skills & experience (Training needs)
  - b. Hostile youth, MH concerns, Pod or Unit tension
6. IS's are expected to have monthly contact and provide written training to all staff assigned to them.
  - a. An IS that is not working with or doesn't have contact with an assigned staff during a rotation will request contact be made by a fellow IS who is able to do so.
  - b. These contacts will be placed in each staff's work site file (WSF) for use in their performance evaluations (PAF).
7. IS's are expected to spend the majority of their time within the Pods of the facility in order to provide active supervision of staff, as well as, maintain optimal performance in the daily operation of the facility.
8. IS's are not to issue any briefings or post orders without supervisor approval.
9. IS's are expected to check ScheduleAnywhere.com on a regular basis for possible changes in their schedule due to coverage issues, i.e., Vacation, LOA, or Training.
10. IS's are to complete staff's PAFs three (3) weeks prior to their due date.
  - a. PAF's to include all WSF entries, personal observations, and accurate personal sick leave usage (Family Sick time or FMLA time is not reported).
