in a way that is demeaning, and inappropriate for young children at the age of 12-15 years o age to read.

#4 What do you feel might be the result of using this material?

The result of young 12-14 year old children reading this is that they will feel there is a social acceptance in having sex between a 16 year old and 17 year old, and that parents aren't really involved in parenting. The mother didn't ask where the girl was going or who she was going with when Hazel said she was going to the movies. The girl lied by omission when no telling her mother she was going to a boys house to watch a movie. Promotes the use of foul language, sexual terminology, sex acts and sexual innuendos not appropriate for young children.

#5 Did you discuss your concern with the teacher?

YES - I called and talked to the 8th grade counselor about my concerns. She went to the librarian, and told me in a later conversation, that the librarian said it was not on a "do not place on shelf list". I was told by the librarian in front of the 8th grade counselor that if I had a concern about the book that I needed to go to the "District" and to talk to the "instructional materials dept".

The book had been announced over the public address system during 7th period a couple of months ago, that it was now "in the library". I heard it when I was parked outside the school. I didn't know anything about the book, but assumed it was "approved" reading.

#6 Did you discuss your concern with your son/daughter? YES

#7 What would you like us to do about the material?

Either remove it from the library, and notify the district that it shouldn't be approved for elementary school reading, or send home a permission slip for a signature from the parent warning them that there is adult subject matter and adult language in the book.
